## WHAT IS THE PRODUCT?

### Product Type:

This Fund is a Sub-Fund of Navigate Funds SICAV PLC which is an open-ended Collective Investment Scheme with variable share capital which was incorporated in Malta on 22 June 2016 under registration number SV415 and is authorised by the Malta Financial Services Authority as an UCITS.

### Maturity Date:

This Sub-Fund has no maturity date.

### Investment Objective:

The objective of the Navigate Climate Volatility Opportunities Fund is to provide both income and growth through a total return approach while controlling risk. The Sub-Fund will aim to achieve annual returns of 3% over 1 Month LIBOR, and to deliver an absolute return over rolling 48 month periods. In other words, at any one time the portfolio of the Navigate Climate Volatility Opportunities Fund will typically be constructed with reference to an investment horizon of no greater than 48 months.

The Sub-Fund aims to achieve its investment objective by investing primarily in a portfolio of income generating asset classes globally by pursuing the strategy detailed below. It is not proposed to concentrate investments in any one geographical region or sector.

There is no guarantee that the investment objective of the Sub-Fund will be achieved, and investment results may vary substantially over time.

### Investment Policy:

The Navigate Climate Volatility Opportunities Fund aims to achieve its objective principally through direct and/or indirect exposures to equities listed on the London Stock Exchange and/or other Approved Regulated Markets, and through strategic portfolio allocation which may apart from equities (including both dividend paying equities and otherwise), consist of fixed income securities, investment trusts (including REITs) eligible collective investment schemes, deposits, currencies, commodities, infrastructure, convertibles and/or financial derivative instruments (FDIs). Indirect equities exposures will also be achieved using UCITS eligible collective investment schemes (CIS). Equity exposures will in most cases, be towards mid-to-large cap companies.

The Sub-Fund aims to invest in companies which have embraced sustainability in ESG, to support companies that have embraced this agenda. The Sub-Fund will generally invest in those businesses which are seeking to make a net positive contribution to sustainability.

Transactions in derivatives Subject to the below leverage restrictions, the Sub-Fund may use exchange traded and OTC derivatives generally to hedge currency exposure and minimise volatility in each Investor Share Class. may be used for the purposes of hedging in accordance with UCITS regulations.

The level of leverage under normal market circumstances is expected to amount to 150% of the Net Asset Value of the Fund. Such level might be exceeded or might be subject to change in the future.

### Benchmark Rate:

The Sub-Fund is not managed in reference to a benchmark.

### Dealing Frequency:

Investors may subscribe and redeem to units on a daily basis.

### Distribution Policy:

The following classes of Investor Shares are designated as Distribution Shares:

- Class F10 Shares;
- Class G10 Shares;
- Nexus Global Income Portfolio Class A Distribution Shares – GBP, EURO, USD;
- Nexus Global Income Portfolio Class B Distribution shares – GBP

In these share classes net income is intended to be distributed by way of dividend twice a year after the Interim and Final Results.

### Target Market (Suitable For):

This Sub-Fund is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a high level of risk of loss to their original capital in order to get a higher potential return

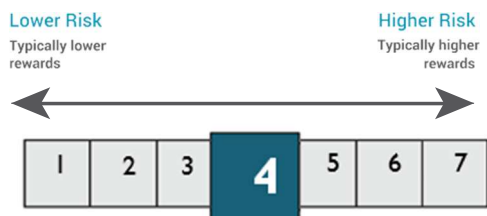

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN



The Summary Risk Indicator (SRI) is a guide to the level of risk of this product. It helps you assess risk and compare it with other products. It shows how likely it is that the product will lose money and whether the money you have invested has some form of protection.

The figure is based on 5 years of weekly performance data, where available. If 4 years of weekly data is not available for the sub-fund then the figure has been determined based on qualitative criteria limited to the nature of the product.

The risk indicator assumes you keep the product for the recommended holding period which can be found below. The risk can vary significantly if you cash in at a time, other than the end of the recommended holding period.

We have classified this Sub-Fund as 4 out of 7, which is medium risk. This rates the potential losses from future performance at a medium level and poor market conditions could impact the capacity of the Navigate SICAV to pay you should you redeem your investment. The Sub-Fund may be exposed to risks not included in the SRI including, but not limited to, the following:

**Instrument risk:** The Sub-Fund invests in securities that may go up or down daily for a variety of reasons including changes in interest rates, inflation expectations, perceived credit quality of the issuer, perceived value of underlying instrument or positive or adverse news.

**Counterparty risk:** As the Sub-Fund may enter into derivative agreements there is a risk that other parties may fail to meet their obligations. This may lead to delays in receiving amounts due to the Sub-Fund, receiving less than is due or receiving nothing.

**Currency risk:** As the Sub-Fund invests in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.

**Market risk:** The Sub-Fund holds no capital protection against market risk which cause the value of your investment to increase or decrease.
